I hope the version of the Postmark finds you and your family members healthy. This year has been a difficult one so far in regards to advocating a safe and healthy workplace for the members of St. Paul Area Local.

In February, I started a conversation with the District Manager to start getting together a plan for responding to an invisible threat which had the potential to impact our workforce. This discussion was started before anything started to be affected here, just was challenging them to be ready if it were to occur. By this time the supply chain to receive the necessary supplies was struggling to provide the supplies. Soon after this, the first case of postal workers infected was happening in the State of Washington and the supplies rerouted to affected areas. It seems like since this time, new agreements and cleaning processes have been evolving to respond to growing threat.

I want to thank the members of St. Paul APWU Local, the officers and stewards as they have faced this worry and anxiety each of us are facing. The St. Paul Area Local has relied on its members to reach out to us and provide information concerning their work area. We are committed to responding and try and help each and every time and employee recognizes an issue. There have been a lot of creative ideas implemented and we are better for the suggestions. We continue to the need this communication so we can represent you our members.

At the writing of this article some eight weeks after the first diagnosis in MN and WI we have not had a single positive test reported from our members. I'm still amazed at this fact. I certainly believe it will happen sooner than later and will respond by having management provide a full accounting of how they intend to provide the safe and healthy work environment agreed to in our Contract.

I would like to publicly thank District Manager Tony Williams. He has without hesitation stepped in to help us provide safe and healthy environment where we are struggling with a facility's supervisors or Managers at every turn we have needed.

At the end of March when the Governor of MN is-

sued his shelter at home order, our Local office needed to sent our secretaries home. We worked together and they were able to accomplish a great deal of their work



from their homes. As of today, and following the Governor's order we have developed a plan for them to return to work and have a written plan in place that provides the necessary cleaning and physical distancing required.

Right now, our General Membership Meetings have been cancelled due to the no more than 10 people gathered together prohibition. It is anticipated this will also impact the May meeting also. Please watch the Local website and Flash Bulletins we send to your office to announce the next meeting whether is scheduled or cancelled.

Also, if you are tested stay home until the results are given to you. Protecting your co-workers is also vitally important.

ST. PAUL AREA RETIREES CHAPTER APWU NOTICE OF ELECTION OF OFFICERS

In accordance with the Constitution and Bylaws of the St. Paul Area Retirees Chapter APWU at Article 5, in its entirety, as follows:

Election of officers shall be held by secret ballot at the May 20, 2020 regular meeting of the Chapter. Officers are elected to a two (2) year term. To be eligible for office the candidate must be a member in good standing for three months preceding the election.

Offices to be filled and duties related thereto are:

<u>President</u>: Shall preside over all membership meetings and meetings of the Chapter's Executive Board; shall be a member of all committees, except the Election Committee

Countersign all checks drawn against the funds of the Chapter.

Appoint all standing committees and special committees of the Chapter, subject to the approval of the Executive Board.

Report to the membership regarding the progress and standing of the Chapter, subject to the approval of the Executive Board.

The President is responsible for filling vacant offices, both general and administrative, subject to the approval of the Executive Board.

Recording Secretary:

Keep a record of the proceedings of all Chapter meetings and all Executive Board meetings.

Countersign all checks drawn against the funds of the Chapter and perform as the Executive (sic, Board) may require.

Treasurer:

The treasurer shall receive and receipt all funds of the Chapter as well as prepare and file annual IRS tax forms.

Trustee:

Will form an audit committee of Officers from the St. Paul Area Local to conduct a yearly audit of all expenses and revenues of the Chapter. In the absence of the President they shall preside to the business of the Chapter.

WHERE ARE WE NOW?

With everything that's happening at such a rapid pace I thought it would be interesting to compare where we started, where we are now (March 22) and where we will be when you read this article. On March 1 we were told that one of the 1st postal employees from the Seattle NDC was diagnosed with COVID19. At that time there were only a couple hundred confirmed cases in the country. The Dow and S&P had been dropping from their all time highs for about a week (29,423 and 3,386) but everything else was pretty normal. The next two weeks were still pretty calm even through the cases continued to rise. There was definitely a shortage of hand sanitizers, Clorox wipes and surprisingly toilet paper.

Then around March 14 everything escalated quickly, governors started implementing business to close down which included; movie theaters, gyms, dine-in restaurants.... Also no meetings, gathering or events of more then 10 people, everyone should stay 6 feet apart. Schools are suspended until April 3, the postal service starts instructing employees if you're sick: stay home. Several agreements between the postal service and the Union are signed and we are getting service talks and updates.

As I write this article it is March 22, 2020. Global cases are now at 300,000 with

13,000 deaths. The United States currently has 27,000 cases with 300 deaths. The Dow is now at 19,174 down 33% for the vear and the S&P is at 2.304 or down 29%. You still can not get hand sanitizers, Clorox wipes and toilet paper. Now stores close earlier for restocking purposes and most stores are low or out of meats, can goods, pastas, breads, rice, eggs and milk. Gas price have dropped almost a dollar and is at \$1.55 a gallon. Currently there is no postal employee in the St Paul bid cluster or Northland district that has been confirmed to have COVID-19. There are currently 6 states that are on lockdown. The government is debating given everyone 1,000 to 2,000 dollars each.

NOW as you read this article, Forecasters are saying the job numbers that come out on April 3, 2020 will be between -500,000 to -5,000,000. The worst month of job loss during the financial crisis was in March 2009 at -800,000 jobs. My predictions are I think the stock market has continued to drop, several employees in the Northland district including St Paul bid cluster will be confirmed as having COVID-19. I think most or all of the states will have some kind of lockdown in place. I think the stores will be restocked but there will be limits on the quantities. I think the kiddos will finish their school year at home working from the computer and the number of COVID cases is still rising.

Well I did not know that COVID-19 would effect the Postmark which it did. So as of April 30, 2020 this is where we are now. Global cases are at 3,272,000 with 231,310 deaths. The United States currently has 1,076,089 cases with 62,378 deaths. The Dow is now at 24,266 and the S&P is at 2,902 which has recovered about 2/3 of its loss. You still cannot get hand sanitizers or Clorox wipes but everything else is mostly available. Currently there is no postal employee in the St Paul bid cluster that has been confirmed to have COVID-19. We have had a couple employees family members or people they have been in contact with have it but luckily, they quarantined and it did not spread. Minneapolis has just confirmed it's first case and we will be in contact with them to see what happens over there. After about 6 weeks of shut downs they are now opening the state and country back up. So now what's going to happen?
